

#### Game rules

#### 1st Round

Which EU country had the highest VAT revenues in 2019?

- This country was the first to enact daylight saving time in 1916.
- This country had 8 capitals and shares borders with 9 other countries.
- This dish is known as Bratwurst and is one of the country's most famous and popular dishes. Note: An unnamed <u>automaker</u> from this country has Bratwurst as an official component for all its vehicles under item number 199 398 500 A





#### 2nd Round

Which state has the largest tax gap in nominal terms?

- The village of Viganella, located in this state, is located in a deep valley, where mountains block sunlight in winter, so they built huge mirrors around the perimeter to reflect sunshine directly down into the valley.
- This state is one of the founders of the European Union and is a member of the G8, the forum of the eight most powerful nations.
- There are two independent states within that country: the Republic of San Marino (40 square kilometers) and the Vatican (0,5 square kilometers).



#### 3rd Round

Which state recorded the highest increase in the tax gap between 2018 -2019 by 5, 4%?

- Traditional dishes of this country include, "pastizz", "ftira" or "bragioli,..
- It is the smallest country in the European Union.
- In this state, traffic is the same as in the United Kingdom, ie driving on the left-hand side of the road.



#### 4th Round

In which EU country had the highest VAT GAP in 2019 (34.9%)?

- This country is home to four Nobel Prize laureates: George Emil Palade (medicine), Elie Wiesel (peace), Herta Müller (literature), and Stefan Hell (chemistry).
- The eastern shores of the country meet the waters of the Black Sea.
- From this country came the famous historically figure, Count Vlad III.
  Dracula, also called The Impaler.
